President's Message

Dear Members,

Our first ever virtual General Meeting using Zoom was a success!

Many thanks to Bill Newman for his great presentation on making and using "Story Sticks".

During the New Business segment of the meeting, a proposal to change two of our by-laws was presented for your consideration and to be voted on in the August general meeting which will again be a Zoom virtual meeting.

Since many of you were not present I am including the proposed changes along with the current wording.

A brief overview of the changes:

By-law 4 addresses dues and in its current wording all members pay the same amount. The proposed wording makes it clear that both spouses are covered by one membership due. In addition, the proposal adds a clause that students enrolled full time in a college or vocational school can join for 50% of regular membership dues. The proposal was presented as one way to encourage participation by the next generation of woodworkers.

By-law 6 addresses officers & directors and in its current wording specifically states that the board will have a minimum of 6 directors with two being elected each year. The proposed change provides more flexibility in the size of our Board of Directors by stating that 1/3 of the directors will be elected each year. Our Board of Directors currently has 10 directors, each serving a 3 year term. This change will allow the board to have a staggered change of members and not get to a point where we have a complete replacement at one time.

The actual wording of the bylaws with highlighted changes can be found on page 2. These will be voted on in the August meeting so your consideration and vote is important.

Proposed By-law Changes

By-law Four

CURRENT WORDING:

AMOUNT: The annual dues required for membership will be determined by the Board and approved by vote of the active members. Dues may vary from year to year, but will be the same for all active members. Annual dues are due in January each year. If dues are not paid by March 1st, the member shall lose all Guild privileges including use of the WEC.

PROPOSED WORDING:

AMOUNT: The annual dues required for membership will be determined by the Board and approved by vote of the active members. INDIVIDUAL MEMBER DUES WILL INCLUDE BOTH SPOUSES OF A HOUSEHOLD WHEN REQUESTED. A STUDENT ENROLLED FULL TIME IN A COLLEGE OR VOCATIONAL SCHOOL WILL BE REQUIRED TO PAY ONLY 50% OF THE CURRENT MEMBER DUES.

Annual dues are due in January each year. If dues are not paid by March 1st, the member shall lose all Guild privileges including use of the WEC.

By-law Six

CURRENT WORDING:

TERMS: Officers will be elected at the November meeting, and will assume office in January. Officers will serve for a term of one (1) year and until successors are duly elected. Directors will serve three (3) year terms with two being elected each year. Officers are eligible for reelection, limited to two consecutive terms unless waived by the Board. Directors are limited to one term unless waived by the board. Vacancies in any office may be filled for the balance of the term by the Board.

PROPOSED WORDING:

TERMS:

Officers will be elected by ballot at the November General meeting from names of persons submitted to the membership by the Nominating Committee and will assume office in January. Officers will serve for a term of one (1) year and until successors are duly elected. Officers are eligible for re-election, limited to two consecutive terms unless waived by the Board.

The members of the Board of Directors shall be elected by ballot at the November General meeting from names of persons submitted to the membership by the Nominating Committee. Members of the Board of Directors elected shall serve for a period of three years. One-third of the members of the Board shall be elected annually. Directors are limited to one term unless waived by the Board. Vacancies in any office may be filled for the balance of the term by the Board.


Toy Group

There is a New Way to "Clock-In" at the WEC

Now that the WEC has resumed normal open hours and the Special Interest Groups have been untethered with regards to how many SIG members can be onsite, a gentle reminder of the new method for "Clocking In" at the WEC may be in order.



Effective April 1st, a new scanning system: Clock Simple; was installed. This system will allow members to come into the WEC, get their Badge and scan the barcode on the back of their Badge. All of the current members who left their Badge on the Badge Wall in the kitchen have had the barcodes affixed to back of the Badge. Those of you who carry your badge home or leave them in your vehicle will have to see the On Duty Supervisor to learn your badge number before you can Clock In.
